LONG-RANGE ISSUE: 7. THE COURT NEEDS TO REACH OUT TO THE COMMUNITY TO A GREATER EXTENT IN ORDER TO INCREASE UNDERSTANDING OF ITS ROLE AND OPERATIONS. THERE IS A NEED CONSTANTLY TO STRIVE FOR EXCELLENCE IN SERVICE IN ALL THE COURT'S CONTACTS WITH COURT USERS.

Issue Description: This "key result area" has two components: 1) to improve and expand the Court's outreach to the community regarding its role and operations; and 2) to enhance and improve its internal "service excellence".

The Court needs to develop a formal program with local schools to expand student tours of the courts and develop a formal program for judicial officers to address civic groups. These programs will increase the community understanding of what the Court does, how it does it, and its role in the community.

There always is room for improvement in the day-to-day "moments of truth" between Court staff and court users. There also are improvements that can be made in the process of sharing information with court users. Service excellence is one of the values of the Court. Constant vigilance is necessary to achieve continuing improvement.

- A formal program for judicial and senior staff appearances before civic groups and other citizen gatherings to discuss the Court’s work.
 - An expanded program of visits to Court locations by students.
